The Collection and Non-Collection of Children Policy


Parents should always aim to be on time to collect their child at the end of the session; however, we recognise that there may be occasions when a parent/carer is unavoidably late to collect their child. In the event that a child is not collected by an authorised adult by their expected collection time, we put into practice agreed procedures. These ensure that the child is cared for safely by an experienced and qualified member of staff who is known to the child. We inform parents/carers of our procedures so that, if they are unavoidably delayed, they will be reassured that their children will be properly cared for.

Procedures for the collection of children

- At the end of each session, a member of staff will open the door to allow parents/carers to come in and collect their child/ren. The children will be sitting on the rug and encouraged to wait there until their parent or carer arrives.
- No child will be allowed to leave with anyone who is not listed by the parents on the registration form, unless the parents have signed the collection book, giving details and permission for the person to collect the child. Staff will ask for identification from that person upon collection.
- No child will be handed over to anyone under the age of 16. If staff members are in any doubt of the person's age, they will request to see identification.
- Staff will ensure that no child leaves unaccompanied. Procedures for the non-collection of a child
- Parents are asked to provide the following specific information when their child starts attending our setting, which is recorded on our Registration Form: Home address and telephone number if the parents do not have a telephone, an alternative number must be given, perhaps a neighbour or close relative. Mobile telephone number (if applicable). Names, addresses, telephone numbers and signatures of adults who are authorised by the parents to collect their child from the setting, for example a childminder or grandparent. Details of who has parental responsibility for the child. Information about any person who does not have legal access to the child. It is the parent's responsibility to ensure that we have up to date contact details for both parents and all persons whom they have nominated as an emergency contact and nominated collector.
- On occasions when parents, or the persons normally authorised to collect the child, are not able to collect the child, they provide us with written details of the name, address and

telephone number of the person who will be collecting their child. We agree with parents how to verify the identity of the person who is to collect their child.

- Parents are informed that if they are not able to collect the child as planned, they must inform us so that we can begin to take back-up measures. Our contact telephone number is 07709052158
- We inform parents that in the event of their child not being collected from preschool by an authorised adult and the staff can no longer supervise the child at our premises, we apply our safeguarding procedures as set out in our 'Safeguarding Children' policy. If a child is not collected at their expected collection time, we follow the procedures below:
- The child's file is checked for any information about changes to the normal collection routines. If no information is available; parents/carers are contacted at home or at work.
- If this is unsuccessful, the adults who are authorised by the parents to collect their child and whose telephone numbers are recorded on the Registration Form are contacted.
- All reasonable attempts are made to contact the parents or nominated carers.
- The child does not leave the premises with anyone other than those named on the Registration Form or in their file.
- If no-one collects the child within 30 minutes of their expected collection time and there is no named contact who can be contacted to collect the child, we apply the procedures for uncollected children.
- If we have any cause to believe the child has been abandoned we will contact the local authority children's social care team. If the children's social care team is unavailable, or if our local authority advises, we will contact the local police.
- The child stays at the preschool under the care of two of our fully-vetted workers, one of whom will be our manager or deputy manager, until the child is safely collected either by the parents or by a social care worker, or by another person specified by social care.
- Under no circumstances will staff take the child home with them.
- We will ensure that the child is not anxious and that we do not discuss our concerns in front of them.
- A full written report of the incident is recorded in the child's file.
